The Certima certification logo is as follows:



This regulation for the use of the Certima logo is among others in accordance with the ISO/IEC 17021-1:2015, the ISO/IEC 17065:2012 and the regulations of the certification schemes concerned.

Authorized to use the logo are corporate bodies, which comply with the requirements for certification and with which Certima has entered into a certification contract and which have been granted a certificate. They are called hereafter 'certificate holders'.

Certificate holders are entitled to use the logo on their postal paper, brochures, pamphlets, leaflets and invoices or other use of logo, not being in conflict with this regulation, for as far as such a use is related to activities, such as the development, the production, the distribution of goods for which the certificate is granted. This logo or its applications shall not be used on a product nor product packaging nor in any other way that may be interpreted as denoting product conformity.

On request Certima will deliver the certificate holder against cost price the specification of the logo for use by a printing company.

The requirements for use of the logo are laid down in the following articles.

Design of the logo and the certification declaration

The Certima logo contains two words – “Certima” and “Certainly”. The word certainly is positioned under the word Certima. The letter “i” of Certima represents a stylized image of a tree with leaves shaded with colors varying from blue to green and a stem shaded from blue to green. The rest of the letters of “Certima” are black. The letters of “Certainly” are light green with slight shades of blue. The background the whole picture is white.

If this does not fit with the rest of the make up of the certificate holder’s documents the color full-black for the text together with a grey contrasting background is the permitted alternative.

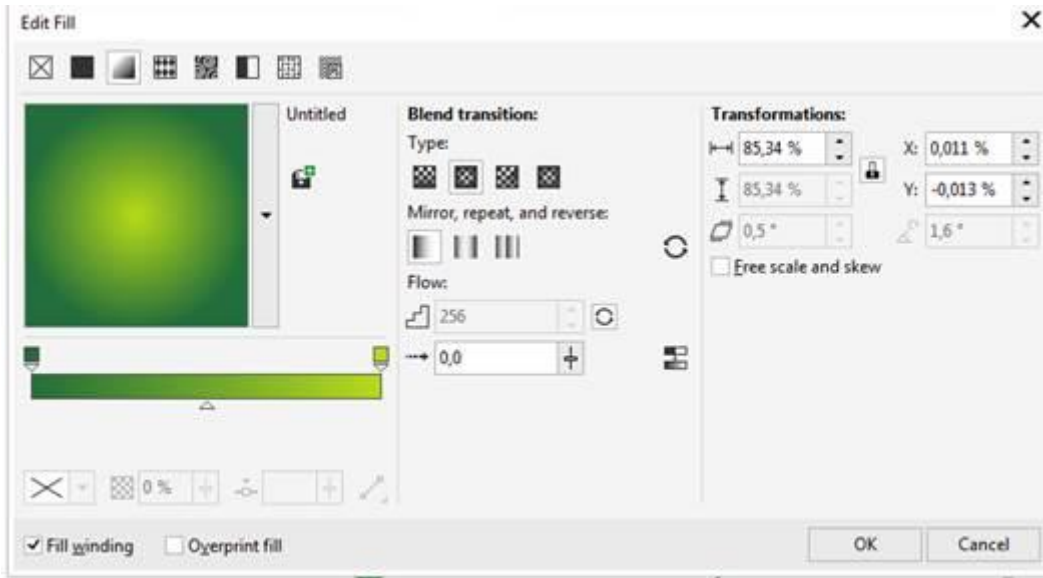
Colors

The RGB values of the colors, used for the logo are as follows:

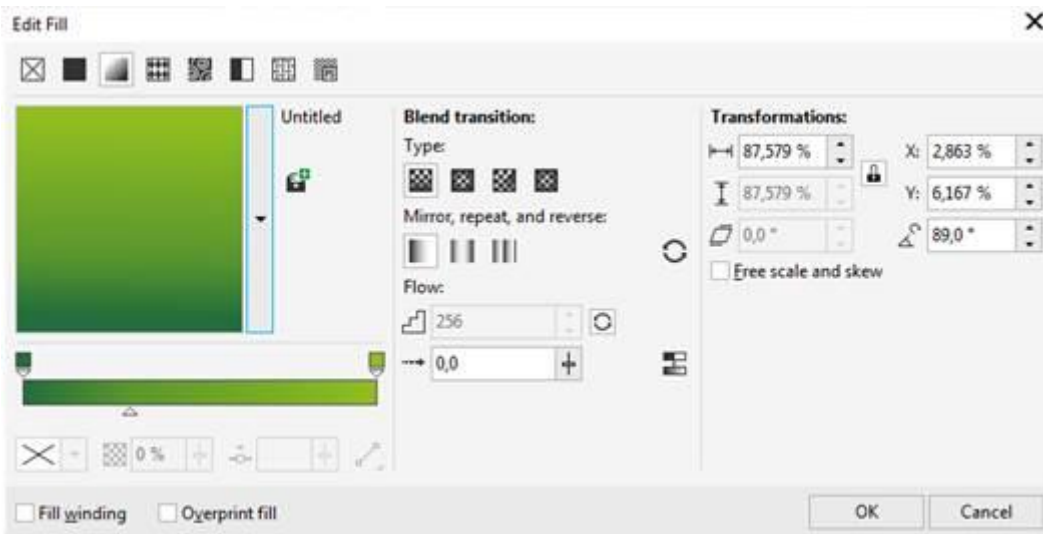
- Black text: C:0 M:0 Y:0 K:0
- Logo basic dark green: C:90 M:30 Y:95 K:30
- Logo basic light green: C:41 M:0 Y:100 K:3
- Text basic dark green: C:90 M:30 Y:95 K:30
- Text basic light green: C:42 M:5 Y:81 K:8

Certificate holder's declaration

The certificate holder's declaration can be posted on publicity materials such as – business cards, website, leaflets, flags, and vehicles.

The certificate holder's declaration cannot be posted on the products and their packing facing consumers.

Use and surveillance on the usage of the logo and of the certification declaration

It is allowed to use the logo only together with the name and logo of the certificate holder concerned. The logo should not be more obvious, e.g. larger in terms of size or brighter in terms of colors or more impressive in terms of number of repetitions per page. Other usage of the logo is only allowed with written permission of Certima. The approval of Certima is required for each other form of usage of the logo not mentioned in this regulation.

The certification declaration shall always be printed close to the certificate holder together with the certificate registration number and with the Certima logo. The declaration and the Certima logo shall not be more notable than the certificate holders' name.

It is not permitted the Certima logo to be applied to laboratory test, calibration or inspection reports or certificates.

The certificate holder shall assure that his customers do not use this certification declaration and the Certima logo in any way.

Certima will survey the certificate holder on the correct usage.

If the certificate holder loses the certificate due to termination of the certification agreement or due to withdrawal or expiring of the certificate, it is directly forbidden for the company concerned to use the logo and or the certification declaration any longer.

All rights and obligations as well penalties in relation to the use of the logo are mentioned in the certification agreement that is applicable between Certima and the certificate holder.
